

On approval of the Model Regulations for admission to studies in educational organization, implementing educational programs of technical and vocational education

In accordance with subparagraph 11) of Article 5 of the Law of the Republic of Kazakhstan dated July 27, 2007 "On education" and subparagraph 1) of Article 10 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On public services" **I HEREBY ORDER**:

Footnote. The preamble - as amended by Order of the Minister of Education and Science of the Republic of Kazakhstan dated 08.06.2020 No. 237 (shall come into effect after the day of its first official publication).

- 1. To approve the annexed Model Regulations for admission to studies in the educational organization, implementing educational programs of technical and vocational education.
- 2. The Technical and Vocational Education Department of the Ministry of Education and Science of the Republic of Kazakhstan in accordance with the legislation of the Republic of Kazakhstan shall:
- 1) ensure the state registration of this order with the Ministry of Justice of the Republic of Kazakhstan;
- 2) within ten calendar days from the date of the State registration of this order, send it in the Kazakh and Russian languages to the Republican State Enterprise on the Right of Economic Management "Republican Center of Legal Information of the Ministry of Justice of the Republic of Kazakhstan" for official publication and inclusion in the Reference Control Bank of Regulatory Legal Acts of the Republic of Kazakhstan;
- 3) within ten calendar days after the state registration of this order, submit its copy for the official publication in periodical editions;
- 4) place this order on the Internet resource of the Ministry of Education and Science of the Republic of Kazakhstan after its official publication;
- 5) within ten working days after the state registration of this order, submit the information to the Legal Service Department of the Ministry of Education and Science of the Republic of Kazakhstan on execution of the measures provided by subparagraphs 1), 2) 3) and 4) of this paragraph.

- 3. Vice-Minister of Education and Science of the Republic of Kazakhstan Sukhanberdiyeva E. shall be authorized to oversee the implementation of this order.
- 4. This order shall be enforced upon expiry of ten calendar days after its first official publication.

# Model rules for admission to training in educational organizations implementing educational programs of higher education

Footnote. Model rules as amended by Order of the Minister of Education and Science of the Republic of Kazakhstan dated June 14, 2019 No. 269 (shall come into effect after the day of its first official publication).

### Chapter 1. General provisions

1. These Model rules for admission to training in educational organizations implementing educational programs of higher education (hereinafter referred to as the Model Rules) have been developed in accordance with subparagraph 11) of Article 5 of the Law of the Republic of Kazakhstan dated July 27, 2007 "On Education" (hereinafter referred to as the Law) and subparagraph 1) of Article 10 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On public services", which determine the procedure for admission to training in educational organizations implementing educational programs of higher education and the provision of public services "Acceptance of documents and enrollment in higher educational institutions for training on educational programs of higher education".

2. Admission of persons entering educational institutions of the Republic of Kazakhstan, implementing educational programs of higher and (or) postgraduate education (hereinafter referred to as OHPE) shall be carried out by placing a state educational order and educational grant of higher education at the expense of the republican budget or local budget, as well as payment training at the expense of the student's own funds and other sources.

# Chapter 2. The procedure for admission to educational institutions implementing educational programs of higher education

- 3. Persons with general secondary, technical and professional, post-secondary, higher education shall be admitted to OHPE.
- 4. To the competition for the award of an educational grant of higher education at the republican budget or the local budget expense and (or) enrollment in paid education, persons shall be admitted with secondary, technical and vocational or post-secondary education, with the exception of those enrolling in related areas of training of higher education specialists with reduced training terms, who passed the UNT and scored in it:
- in the national OHPE at least 65 points, and in the "Pedagogical Sciences"- at least 75 points, in the "Healthcare" education field at least 70 points, in the education fields " Agriculture and bioresources", "Veterinary Medicine" at least 60 points;
- in other OHPE at least 50 points, and in the "Pedagogical Sciences" education field at least 75 points, in the "Healthcare" education field at least 70 points.

At the same time, for each subject of the UNT and (or) a creative exam, it is necessary to score at least 5 points.

To participate in the competition for the award of an educational grant of higher education at the expense of the republican budget or the local budget and (or) enrollment in paid education in related areas of training higher education specialists, providing for reduced training terms, persons shall be admitted with technical and vocational, post-secondary education who have passed UNT and those who scored at least 25 points in it and at least 35 points in the education field "Pedagogical Sciences", including at least 5 points on each discipline of the UNT and (or) creative exam.

In the UNT in electronic format in the competition for an educational grant of higher education at the expense of the republican budget or the local budget, the applicant shall participate with one of two UNT results with the required points specified in this paragraph.

4-1. Persons who have certificates of international standardized tests SAT, ACT, IB participate in the competition for the award of an educational grant and (or) are enrolled in universities for a fee-based department, in accordance with the scale of transfer of points, according to the Annex 2-1 to these Model Rules. The transfer of SAT points to the UNT shall be carried out subject to the availability of SAT reasoning and SAT subject certificates. In this case, the results of the SAT subject shall be converted into UNT points, if the profile subjects coincide.

Footnote. The Rules have been supplemented with paragraph 4-1 in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated 08.06.2020 No. 237 (shall come into effect after the day of its first official publication).

5. OHPE, in accordance with subparagraph 6) of paragraph 2 of Article 43-1 of the Law, shall determine the procedure for admission, the form, the program for conducting an additional examination and (or) a passing score for applicants, taking into account the specifics of the direction of training, with the exception of applicants specified in paragraphs 8 and 9 of Article 26 of the Law.

Acceptance of an application for participation in an additional examination, as well as its conduct by the OHPE, shall be carried out from 01 to 20 August.

Applicants shall submit an application for participation in an additional examination in the declared OHPE in accordance with the established points of paragraph 4 of these Model Rules.

An applicant shall be enrolled in the OHPE, subject to his passing an additional examination and (or) the passing threshold score set by the OHPE.

6. Citizens of the Republic of Kazakhstan with technical and professional, post-secondary or higher education shall be admitted to study in educational programs of higher education, providing for a shorter study period.

The admission to OHPE of persons with technical and professional or post-secondary education with the qualification of "middle-level specialist" or "applied bachelor" in related areas of training for higher education, providing for reduced training periods, those entering fee-based education shall be carried out by the admission commissions of OHPE.

The admission to the OHPE of persons with higher education, according to the group of educational programs that provide for reduced terms of study on a paid basis, shall be carried out by the admission commissions of the OHPE.

7. The admission of foreign citizens according to the allocated quota based on an educational grant to international OHPE, created based on interstate agreements, shall be carried out by OHPE independently.

The admission of foreign citizens to study at the OHPE on a paid basis shall be carried out according to the results of an interview conducted by the admission commissions of the OHPE during the calendar year. In this case, the enrollment of foreign citizens shall be carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.

Thus, the admission of foreign citizens based on an educational grant and on a paid basis shall be carried out by the OHPE, accredited in accordance with Article 9-1 of the Law.

- 8. Upon admission to study at OHPE, an admission quota shall be provided in the amount approved by the Resolution of the Government of the Republic of Kazakhstan dated February 28, 2012 No. 264 "On approval of the admission quota for admission to study in educational organizations implementing educational programs of technical and professional, post-secondary and higher education".
- 9. Admission of persons entering the OHPE shall be carried out on their applications on a competitive basis, in accordance with the points of the certificate of the established sample, in the form approved by the Order of the Acting Minister of Education and Science of the Republic of Kazakhstan dated October 23, 2007 No. 502 "On approval of the form of strictly accountable documents used by educational organizations in educational activities" (registered in the Register of State Registration of Normative Legal Acts under No. 4991) and (or) an electronic certificate with unique applicant data, officially confirming the results of the unified national testing (UNT) published on the website of the National Testing Center (hereinafter referred to as the UNT certificate).

- 10. Admission to study on an educational grant for certain groups of educational programs of higher education, requiring work with state secrets, shall be carried out in OHPE, which have permission from the national security authorities in accordance with the legislation of the Republic of Kazakhstan on state secrets.
- 11. Acceptance of documents from applicants to the OHPE, carrying out training of pilots, for participation in the competition for the award of an educational grant of higher education at the expense of the republican budget or the local budget, shall be carried out by the admission committee of this OHPE, with the obligatory submission of a medical examination in medical-flight expert committees, the issuance of a medical opinion on the suitability for training at the OHPE for the training of pilots, in accordance with the Order of the Minister of Defense of the Republic of Kazakhstan dated July 2, 2015 No. 373 "On approval of the Rules for conducting military medical expertise and the Regulation on the bodies of military medical expertise in the Armed Forces of the Republic Kazakhstan" (registered in the Register of State Registration of Normative Legal Acts under No. 11846).
- 12. In each OHPE, an admission committee shall be created by the decision of the head or the person acting in his capacity. The admission committee shall include the head of the OHPE, vice-rectors, heads of structural divisions and representatives of the OHPE teaching faculty. The admission committee must consist of an odd number of members. The admission committee chairman must be the head of the OHPE. By order of the head of the OHPE or the

person acting in his capacity, the executive secretary of the admission committee shall be appointed.

At the same time, the OHPE shall not carry out admissions in the following cases:

- 1) adoption of a decision by the authorized body on suspension, revocation and deprivation of the license and (or) application to the license to engage in educational activities :
- 2) suspension, revocation or expiration of accreditation, with the exception of educational organizations under the President of the Republic of Kazakhstan and military, special educational institutions;
- 3) upon detection of gross violations based on the state control results and (or) during the legal proceedings in the wake of its results;
- 4) absence or exclusion of the curriculum from the authorized education body's Register of curricula for the corresponding curricula group.

### Paragraph 1. The procedure for admission and conduct of special and (or) creative examinations

13. In the admission to training in groups of educational programs of higher education requiring special and (or) creative preparation, including in the education areas "Pedagogical Sciences" and "Healthcare", the results of special and (or) creative examinations shall be taken into account.

Footnote. Paragraph 13 - as amended by Order No. 241 of the Minister of Education and Science of the Republic of Kazakhstan dated 24.05.2021 (effective after the date of its first official publication).

14. For the organization and conduct of special and (or) creative examinations, by the decision of the head of the OHPE or the person acting in his capacity, an examination committee shall be created for the examination period.

The committee shall comprise representatives of the OHPE from among the teaching faculty, public organizations, and the media. The committee for creative examinations in the training areas "Art" and "Training of teachers with a subject specialization of general development" shall also comprise persons with the appropriate education in the relevant area and recommended by the local authorized body in the field of culture and sports.

The examination committee shall not include members of the appeal committee.

The committee shall consist of an odd number of members, and the chairman of the committee is elected by the majority of votes from among the committee members. The decision of the committee shall be considered valid if at least two thirds of its members are

present at the meeting. The decision of the committee shall be made by the majority vote of those present at the exam. In case of equality of votes, the chairman of the committee shall have the decisive vote.

15. Conducting special and (or) creative examinations shall be carried out by groups of educational programs, in accordance with the List of groups of educational programs, for which special and (or) creative examinations are held in accordance with Annex 1 to these Model Rules.

Persons applying for educational programs of higher education requiring special and (or) creative training, including in the field of education "Pedagogical Sciences", for passing special and (or) creative examinations, shall submit the following documents to the admission committee of the OHPE:

- 1) a document on general secondary or technical and professional, post-secondary education (original);
  - 2) 2 photographs of 3x4 cm;
  - 3) a copy of an ID;
  - 4) UNT certificate (if any);
- 5) a copy of a document confirming the presence of one of the sports categories and (or) sports titles established by paragraph 1 of Article 35 of the Law of the Republic of Kazakhstan dated July 3, 2014 "On Physical Culture and Sports" (if any).
- 16. The OHPE shall accept applications from applicants for a creative exam from June 20 to July 7 of the calendar year.

The creative exam shall be held from 8 to 13 July of the calendar year.

When conducting the UNT in electronic format, acceptance of applications from applicants for a creative exam is carried out at the OHPE from June 20 to July 7 of the calendar year.

When conducting the UNT in electronic format, the creative exam shall be held from July 8 to July 13 of the calendar year.

17. Persons entering the group of educational programs of higher education requiring creative training, having documents on general secondary, technical and professional or post-secondary education, take two creative examinations.

Persons entering a group of educational programs of higher education requiring creative training in related areas of training for higher education personnel, providing for a reduced study period, take one creative examination.

The form for conducting special and (or) creative examinations shall be established in accordance with Annex 2 to these Model Rules.

18. Acceptance of applicants' documents and a special admission exam in "Pedagogical Sciences" to the OHPE, in the "Healthcare" education field shall be conducted at the location of the healthcare education organization or of medical faculties (departments) of the OHPE from June 20 to August 24 of the calendar year.

For the UNT in electronic format, the acceptance of applicants' documents and a special enrollment exam in "Pedagogical Sciences" education field to the OHPE, in the "Healthcare" education field shall be conducted at the location of the healthcare education organization or of medical faculties (departments) of the OHPE in the period from June 20 to August 20 of the calendar year.

19. Persons entering the group of educational programs of higher education that require creative training, pass creative examinations, in their chosen OHPE.

For persons with secondary or technical and professional, post-secondary education, entering a group of educational programs of higher education that require creative training, the points on the history of Kazakhstan, reading literacy (language of training) shall be taken into account.

For persons entering a group of educational programs of higher education requiring creative training in related areas of training for higher education personnel, providing for a reduced study period, points in a special discipline shall be taken into account.

20. Persons enrolling in the OHPE in the "Pedagogical Sciences" and "Healthcare" education areas shall take one special exam conducted by the OHPE admission committees.

For persons enrolling in the OHPE in the "Pedagogical Sciences" and "Healthcare" education areas, scores shall be taken into account in the history of Kazakhstan, mathematical literacy, reading literacy (language of instruction), two major subjects.

For persons enrolling in the OHPE in the "Pedagogical Sciences" and "Healthcare" education areas in related fields of training higher education specialists, providing for reduced terms of study, scores shall be taken into account in general professional and special disciplines.

- 21. Programs for conducting special and (or) creative examinations are developed by OHPE and approved by the chairperson of the OHPE admission committee.
- 22. The schedule of special and (or) creative exams (form of the exam, date, time and venue, consultations) shall be approved by the chairman of the admission committee and

brought to the applicants' notice before the start of accepting documents and published on the official Internet resource of the OHPE.

23. Admission to the audience (room) of conducting special and (or) creative examinations shall be carried out upon presentation of an identity document.

In this case, special and (or) creative examinations shall be held in classrooms (rooms) equipped with video and (or) audio recording.

- 24. Before the start of special and (or) creative examinations, applicants shall be given examination material and the procedure for drawing up title pages shall be explained, as well as the start and end times of special and (or) creative examinations, the time and place of announcement of the results, and the application procedure on appeal.
- 25. Creative exams for applicants with certificates of general secondary or technical and vocational, post-secondary education shall be assessed on a 45-point system.

A creative exam for applicants in related areas of training higher education professionals, providing for reduced terms of study, shall be assessed on a 20-point system.

A special exam for applicants in the "Pedagogical Sciences" and "Healthcare" education fields shall be assessed in the "admission" or "non-admission" form.

- 26. The results of the creative examination shall be drawn up with a list of grades, the results of a special examination with a list of admission, a protocol of the committee in any form and are transferred to the executive secretary of the admission committee (his/her deputy) to announce the results. The protocol of the committee shall be signed by the chairperson and all members of the committee present.
- 27. The results of special and (or) creative examinations shall be announced on the day of the examination.
- 28. Based on the special exams results in the "Pedagogical Sciences" and "Healthcare" education fields, an applicant shall be issued an extract from the admission sheet to be presented to the OHPE, regardless of the special exam venue.

29. For the period of the examinations in order to comply with the requirements for the special and (or) creative examination, to resolve controversial issues, to protect the rights of

persons passing the relevant examinations, by order of the head of each OHPE or by the person performing his duties, an appeal committee shall be created, the composition of which shall consist of an odd number of members, including its chairperson.

- 30. An application for an appeal is submitted to the chairperson of the appeal committee personally by a person who has passed a special or creative examination, shall be accepted until 13:00 the next day after the announcement of the results of the special or creative examination, and is considered by the appeal committee within one day.
- 31. The decision of the appeal committee is considered valid if not less than two thirds of its composition are present at the meeting. The decision on the appeal on disagreement with the results of a special or creative examination shall be made by a majority vote of the number of members of the committee present. If the votes of the members of the appeal committee are equal, the chairperson's vote is decisive. The work of the appeal committee shall be documented in a protocol signed by the chairperson and all members of the committee present.
- 32. OHPE, regardless of the form of ownership, on the day of completion of the special and (or) creative examination, transfer to the information system of the National Testing Center of the Ministry of Education and Science of the Republic of Kazakhstan the results of the special and (or) creative examination of applicants for participation in the competition for the award of an educational grant of higher education at the expense of the republican budget and (or) enrollment in OHPE for fee-based education.

### Chapter 3. The procedure for enrollment in OHPE

33. For enrollment in OHPE, service recipients shall provide the service provider (through the admission office of OHPE) or through the web portal of "electronic government" www.egov.kz (hereinafter referred to as the Portal) a set of documents provided for in paragraph 8 of the State Service Standard "Acceptance of documents and enrollment in higher educational institutions for training in educational programs of higher education" (hereinafter referred to as the Standard of public services), in accordance with Annex 3 to these Model Rules.

The list of basic requirements for the provision of public services, including the characteristics of the process, the form, content, and result of the provision of services, as well as other information, taking into account the specifics of the provision of public services, shall be given in the Standard of Public Services.

An employee of the service provider shall perform acceptance of a set of documents, their registration, and issuance of a receipt to the service recipient for the receipt of the set of documents on the day of receipt of the application, or, if the service recipient provides an incomplete set of documents, shall refuse to accept documents.

In case of contacting the service recipient through the portal, the status of acceptance of the request for public service is sent to the "personal account", as well as a notification indicating the date and time of receipt of the result of the public service.

The service provider, from the moment of their receipt, shall check the completeness of the documents submitted, in case of incompleteness, prepare a reasoned refusal to further consider the application, which shall be sent in the form of an electronic document to the applicant in the "personal account" on the portal.

If the service recipient provides a full set of documents, the service provider shall be notified of the acceptance of documents for enrollment in the OHPE. After receiving the notification, the service recipient shall submit the original documents to the service provider within the period from 10 to 25 August of the calendar year.

After the documents are accepted, the head of the OHPE shall issue an order to enroll the service recipient as a student of the OHPE.

The service provider shall refuse to provide a public service on the grounds provided for in paragraph 9 of the Public Service Standard.

33-1. The Service Provider shall ensure that information about the stage of rendering a public service is entered into the information system for monitoring the provision of public services in accordance with subparagraph 11) of paragraph 2 of Article 5 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On Public Services".

Footnote. The Rules have been supplemented with paragraph 33-1 in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan No. 237 dated 08.06.2020 (shall come into effect after the day of its first official publication).

33-2. A complaint about the decision, actions (inaction) of the service provider on the provision of public services may be submitted to the name of the head of the service provider, to the authorized body for assessing and monitoring the quality of the provision of public services, in accordance with the legislation of the Republic of Kazakhstan.

The complaint of a service recipient shall be sent to the service provider, in accordance with paragraph 2 of Article 25 of the Law, is subject to consideration within 5 (five) working days from the date of its registration.

The complaint of a service recipient received by the authorized body for the assessment and control over the quality of the provision of public services is subject to consideration within 15 (fifteen) working days from the date of its registration.

In cases of disagreement with the results of the provision of public services, the service recipient shall apply to the court in the manner prescribed by the legislation of the Republic of Kazakhstan.

33-3. Enrollment in the OHPE at the expense of the republican budget or the local budget or on a fee basis shall be carried out by the OHPE admission committees from August 10 to 25 of the calendar year for training in Kazakh, Russian or English by order of the head of the OHPE or a person acting in his capacity.

The Rules have been supplemented with paragraph 33-3 in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated 08.06.2020 No. 237 (shall come into effect after the day of its first official publication); as amended by Order No. 554 of the acting Minister of Education and Science of the Republic of Kazakhstan dated 05.11.2021 (effective after the date of its first official publication).

34. Persons with secondary, technical and vocational or post-secondary education, except for those entering related areas of training of higher education personnel with a shorter study period, who have not reached the threshold score established in paragraph 4 of these Model Rules (based on the UNT results), with the UNT results with inappropriate combinations of major subjects, with canceled UNT results are enrolled in an OHPE for full-time education on a paid basis.

At the end of the academic period of study at OHPE, these persons repeatedly pass the UNT within a year, in accordance with the Rules for conducting unified national testing, approved by Order of the Minister of Education and Science of the Republic of Kazakhstan dated May 2, 2017 No. 204 (registered in the Register of State Registration of Normative Legal Acts under No. 15173) (hereinafter referred to as the Order No. 204).

35. Holders of an educational grant of higher education at the expense of the republican budget or the local budget shall file an application for admission to the OHPE indicated in the certificate and shall be enrolled as students by order of the head of the OHPE or the person acting in his capacity.

Holders of an educational grant of higher education on curricula groups that require creative training are enrolled in the OHPE, in which they were taking creative exams.

Citizens of the Republic of Kazakhstan enrolling on a state grant shall conclude an agreement on working out for at least 3 (three) years in the manner established by Order No. 390 of the Government of the Republic of Kazakhstan dated March 30, 2012 "On approval of the Rules for assigning a specialist to work, granting the right to self-initiated employment, exemption from the obligation or termination of the obligation to work by citizens who

studied on the state educational order, and introducing amendments and additions to Order No . 58 of the Government of the Republic of Kazakhstan dated January 23, 2008 "On approval of the Rules for awarding an educational grant".

36. Persons with secondary or technical and professional, post-secondary education of the current year, who have passed the UNT within the prescribed time limits in accordance with Order No. 204, and scored the threshold score established in paragraph 4 of these Model Rules, shall submit an application addressed to the head of the OHPE or the person performing his duties to enroll in OHPE on a fee basis before receiving a document on general secondary or technical and professional, post-secondary education.

Thus, students of the final 11 (12) grades of secondary education organizations in the period from February 1 to August 25 of the calendar year shall submit an application addressed to the head of the OHPE or the person performing his duties for enrollment in the OHPE on a fee basis before receiving a document on general secondary education.

After receiving a document on general secondary or technical and professional, post-secondary education, applicants submit documents according to the list specified in paragraph 33 of these Model Rules.

37. Persons who have scored the threshold score established in paragraph 4 of these Model Rules, based on the results of the UNT, provided for in paragraph 5 of these Model Rules, shall submit an application addressed to the head of the OHPE or the person performing his duties for enrollment in the OHPE on a fee basis.

The application shall be accompanied by a UNT certificate, a copy of the transcript signed by an authorized person and sealed.

If an incomplete list of documents specified in paragraphs 15, 33, 36, 37 of these Model Rules is provided, the admission committee shall not accept documents from applicants.

38. Enrollment in the OHPE shall be carried out separately for educational programs of higher education and language departments.

When enrolling in educational programs of higher education, for which creative exams are established, the scores for these exams shall be taken into account, with the exception of those enrolling in related areas of training of higher education specialists, providing for reduced terms of study.

When enrolling in the "Pedagogical Sciences" and "Healthcare" education areas the special exam results shall be taken into account.

39. In the case of an applicant taking an educational loan issued by second-tier banks, the applicant shall be enrolled in the number of OHPE students upon presentation of an appropriate certificate from the bank about the documents being considered.

Thus, he/she shall be provided with a postponement to pay for the amount established in the contract for the provision of educational services and payable before the enrollment of a citizen, for the period of issuing an educational loan, but not more than 4 (four) weeks from the date of receipt of a certificate from the bank.

40. Documents in a foreign language shall be provided with a notarized translation into Kazakh or Russian.

Education certificates issued by foreign educational organizations shall undergo the procedure of nostrification of documents on education in accordance with the procedure established by the legislation of the Republic of Kazakhstan after enrollment of persons during 1 (first) academic period of study.

# Model rules for admission to training in educational organizations implementing educational programs of postgraduate education

Footnote. Model rules as amended by Order of the Minister of Education and Science of the Republic of Kazakhstan dated June 14, 2019 No. 269 (shall come into effect after the day of its first official publication).

### Chapter 1. General Provisions

1. These Model rules for admission to training in educational organizations implementing educational programs of postgraduate education (hereinafter referred to as the Model Rules) have been developed in accordance with subparagraph 11) of Article 5 of the Law of the Republic of Kazakhstan dated July 27, 2007 "On Education" (hereinafter referred to as the Law) and subparagraph 1) of Article 10 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On public services" which determine the procedure for admission to training in educational organizations implementing educational programs of postgraduate education and the provision of public services "Acceptance of documents and enrollment in higher educational institutions for training in educational programs of postgraduate education".

Footnote. Paragraph 1 - as amended by Order of the Minister of Education and Science of the Republic of Kazakhstan dated 08.06.2020 No. 237 (shall come into effect after the day of its first official publication).

2. Enrollment of magistrands, doctoral students of higher and postgraduate education organizations (hereinafter - OHPE) shall be carried out by placing a state educational order

for training professionals in scientific, pedagogical and specialized areas, as well as paying the tuition fee at students' own expense and from other sources.

Enrollment of residency students of healthcare educational organizations, OHPE and scientific organizations (hereinafter referred to as scientific organizations) shall be carried out by placing a state educational order, as well as paying the tuition fee at the expense of students' own funds and other sources.

Alongside this, the OHPE shall not carry out admission in the following cases:

- 1) adoption of a decision by the authorized body on suspension, revocation and deprivation of the license and (or) application to the license to engage in educational activities :
- 2) suspension, revocation or expiration of accreditation, with the exception of educational organizations under the President of the Republic of Kazakhstan and military, special educational institutions:
- 3) upon detection of gross violations based on the state control results and (or) during the legal proceedings based on its results;
- 4) absence or exclusion of the curriculum from the Register of educational programs of the authorized education body for the corresponding group of educational programs.

# Chapter 2. The procedure for admission to training in educational organizations implementing educational programs of postgraduate education

3. Admission of persons to magistracy, doctoral studies, including targeted training, residency of educational organizations in the field of health care, general education institutions and scientific organizations shall be carried out on a competitive basis, based on the results of comprehensive testing (hereinafter referred to as CT) or entrance examinations.

Admission of foreigners to magistracy, doctoral studies, and residency shall be carried out on a fee basis. The receipt by foreigners on a competitive basis in accordance with the state educational order of free postgraduate education shall be determined by international treaties of the Republic of Kazakhstan, with the exception of the scholarship program for master's programs.

- 4. The admission of foreign citizens to study at the OHPE or scientific organizations on a fee basis shall be carried out according to the results of an interview conducted by the admissions committees of the OHPE or scientific organizations during the calendar year. Enrollment of foreign citizens shall be carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.
- 5. Education certificates issued by foreign educational organizations shall be nostrificated in accordance with the procedure established by law.

Documents in a foreign language shall be provided with a notarized translation into Kazakh or Russian.

Education certificates issued by foreign educational organizations shall undergo the procedure of nostrification of documents on education in accordance with the procedure established by the legislation of the Republic of Kazakhstan after enrollment of persons during 1 (first) academic period of study.

Footnote. Paragraph 5- as amended by Order No. 207 of the Minister of Education and Science of the Republic of Kazakhstan dated 06.05.2021 (shall be enforced ten calendar days after the date of its first official publication).

6. An admission committee shall be created to receive documents and organize entrance examinations at the OHPE and scientific organizations. The chairperson of the admission committee shall be the head of the OHPE or scientific organization or the person performing his duties.

The composition and functions of the admission committee shall be approved by the order of the head of the OHPE or scientific organization or the person acting as him.

For applicants for doctoral studies and residency, the admission committee shall carry out:

- 1) advising applicants on the issues of the chosen group of educational programs of postgraduate education, familiarization with the procedure of the entrance examination;
  - 2) organization of reception and verification of documents of applicants;
  - 3) organization of the entrance examination by groups of educational programs.

For applicants to the magistracy, the admission committee shall carry out:

- 1) advising applicants on the issues of the chosen group of educational programs of postgraduate education, familiarization with the CT procedure and/or the entrance (creative) exam;
- 2) organization of the entrance examination in the Arabic language and (or) the creative examination by groups of educational programs.

- 7. Acceptance of applications from enrollees to magistracy at the OHPE shall be conducted by the OHPE admission committees and (or) through the information system of the NTC on the following dates:
  - 1) from June 1 to July 15 of the calendar year;
  - 2) from 5 to 18 November of the calendar year.

The enrollment exam in Arabic and creative exams for applicants to magistracy shall be held at the OHPE on the following dates:

- 1) from 16 to 25 July of the calendar year;
- 2) from 13 to 15 December of the calendar year.

Acceptance of applications for residency in healthcare education organizations, as well as OHPE, shall be conducted by the OHPE admission committees from July 3 to July 25 of the calendar year. Enrollment exams for residency shall be held from 8 to 16 August of the calendar year.

Acceptance of applications for doctoral studies at the OHPE shall be conducted by the OHPE admission committees and (or) through the information system of the NTC on the following dates:

- 1) from July 3 to August 3 of the calendar year;
- 2) from 5 to 18 November of the calendar year.

Enrollment examinations on groups of educational programs for doctoral studies shall be held on the following dates:

- 1) from 4 to 20 August of the calendar year;
- 2) from November 19 to December 11 of the calendar year.

When filing documents, the applicant indicates one OHPE and one group of educational programs.

Persons enrolling for doctoral studies shall provide the following package of documents:

- 1) an application in any form;
- 2) a document on education (original, when submitting documents to the admission committee);
  - 3) identity document (required for personal identification);
  - 4) a certificate of a foreign language proficiency:

English: IELTS Academic (International English Language Testing System Academic) threshold score - at least 5.5;

TOEFL IBT (Test of English as a Foreign Language Internet-based test), threshold score - at least 46;

TOEFL PBT (Test of English as a Foreign Language Paper-based test), threshold score - at least 453;

TOEFL ITP (Test of English as a Foreign Language Institutional Testing Program), threshold score - at least 460;

German: Deutsche Sprachpruefung fuer den Hochschulzugang (DSH, Niveau B2/level B2), TestDaF-Prufung (Niveau B2/level B2);

French: TFI (Test de Français International<sup>TM</sup>) - not lower than B2 level in reading and listening sections), DELF (Diplome d'Etudes en Langue française) - level B2, DALF (Diplome Approfondi de Langue française) - level B2, TCF (Test de connaissance du français) - at least 50 points;

5) a medical certificate of 075 / y form in electronic format, approved by order No. ҚР ДСМ-175/2020).

In the events of restrictive measures, a state of emergency, occurrence of social, natural and man-made emergency situations in a certain territory, a medical certificate shall be provided directly to the educational organization as these measures are lifted;

- 6) six 3x4 cm photographs;
- 7) personal employment records sheet or another document confirming labor activity, certified by the HR department at the place of work;
- 8) a list of scientific and instructional research works (scientific publications, research plan, essays and other documents) over the last 3 calendar years;
  - 9) results of the preliminary selection (for the education field "Healthcare").

The documents listed in subparagraphs 4) and 7) shall be provided in originals and copies, after verification of which the originals shall be returned to the applicant.

Holders of a certificate (TOEFL ITP (Test of English as a Foreign Language Institutional Testing Program) shall take additional test of English before the start of the enrollment exam to doctoral studies.

The number of test assignments for additional testing of the English language shall be 100 . The maximum score shall be 100 points.

Additional testing for English language proficiency shall be assessed in "admission" or "non-admission" form. At least 75 points must be scored to qualify for admission.

Additional testing for proficiency in English shall be conducted by the NTC in organizations determined by the authorized education body.

Applicants shall be notified about the date, time and venue of additional testing for the English language proficiency through their personal account.

In the event of an incomplete list of documents specified in this paragraph, the admission committee shall not accept documents from applicants.

Enrollment in magistracy and doctorate studies shall be conducted on the following dates:

- 1) from 15 to 28 August of the calendar year;
- 2) from December 26 to January 10 of the calendar year.

Thus, admission to MBA (EMBA) programs shall be carried out by OHPEs accredited in accordance with Article 9-1 of the Law

8. Admission to doctoral studies of educational organizations in the field of health care and OHPE shall be carried out in two stages: preliminary selection, entrance examinations.

Pre-selection of educational organizations in the field of health care and general higher education for doctoral studies shall be carried out before the start of the entrance examinations from February 1 to May 31 of the calendar year.

The procedure for preliminary selection for training in educational programs of doctoral studies shall be determined by educational organizations in the field of health care and OHPE independently.

The results of the preliminary selection for training in educational programs of doctoral studies shall be admission or non-admission to the entrance examinations.

Admission to the groups of MBA and DBA educational programs shall be carried out by OHPE independently.

8-1. The timing of the entrance examinations and admission to the educational programs of the DBA shall be determined by the OHPE independently. Education in the educational programs of the DBA shall be carried out on a fee basis. Thus, admission to DBA programs shall be carried out by OHPEs that have passed accreditation in accordance with Article 9-1 of the Law.

### Paragraph 1. Admission and carrying out CT for magistracy, entrance examination for residency

- 9. Persons who have mastered educational programs of higher education shall be admitted to the magistracy, to residency higher education and internships.
- 10. Persons enrolling in magistracy or residency in the period from August 25 to 28 of the calendar year shall file to the service provider (through the OHPE admission committee) (hereinafter -the service provider) or through the e-government web portal www.egov.kz (hereinafter -the portal) a package of documents indicated in paragraph 8 of the Public Service Standard "Acceptance of documents and enrollment in organizations of higher and (or) postgraduate education for training in educational programs of postgraduate education" (hereinafter -the Public Service Standard), in accordance with Appendix 1-1 to these Model Rules.

The list of main requirements for the public service rendering, including characteristics of the process, the form, content and result of the provided service, as well as other information, given the specifics of the of public service rendering, is given in the Public Service Standard.

Information about identity documents, a document of higher education, a health certificate, a certificate of completed internship shall be filed to the service provider from the relevant state information systems through the e-government gateway.

A service provider's receptionist shall accept the package of documents, register them and issue a receipt to the service recipient on acceptance of the document package in the form approved by Order No.39 of the Minister of Education and Science of the Republic of Kazakhstan dated January 28, 2015 "On approval of types and forms of state-issued educational documents and Rules for their issuance" (registered in the Register of State Registration of Regulatory Legal Acts under No. 10348) (further – order No. 39) on the day of the application acceptance, or in case of an incomplete package of documents provided by the service recipient, the documents shall not be accepted.

In case of applying through the portal, the status of acceptance of the request for the public service, as well as a notification indicating the date and time of the received public service result shall be sent to the service recipient to the "personal account".

Upon receipt of the filed documents, the service provider shall check their completeness, and in case of incompleteness, prepare a reasoned refusal to further consider the application, which is sent in the form of an electronic document to the applicant in the "personal account" on the portal.

If the service recipient provides a full package of documents to the service provider a notification shall be sent of acceptance of documents for enrollment in the OHPE, after receiving the notification, the service recipient shall provide the original documents to the service provider before August 28 of the calendar year.

After receiving the documents, the head of the OHPE shall issue an order to enroll the service recipient as a magistrand or a resident trainee of the OHPE.

The service provider shall deny the public services on the grounds referred to in paragraph 9 of the Public Service Standard.

In the event of a negative response from the coordinating state body or other grounds for a denied public service, the service provider shall notify the service recipient of the preliminary decision on denying the public service, as well as the time and place (method) of the hearing to be able to express to the service recipient the position on the preliminary decision.

Notification of the hearing shall be sent at least 3 working days before the end of the term for the public service provision. The hearing shall be held no later than 2 working days from the date of notification.

Based on the hearing results, the service provider shall issue a permit or a reasoned refusal to render the public service.

10-1. The Service Provider shall ensure that information about the stage of rendering a public service is entered into the information system for monitoring the provision of public services in accordance with subparagraph 11) of paragraph 2 of Article 5 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On Public Services".

10-2. A complaint about the decision, actions (inaction) of the service provider on the provision of public services may be submitted to the name of the head of the service provider, to the authorized body for assessing and monitoring the quality of the provision of public services, in accordance with the legislation of the Republic of Kazakhstan.

The service recipient's complaint sent to the service provider, in accordance with paragraph 2 of Article 25 of the Law, is subject to consideration within 5 (five) working days from the date of its registration.

The service recipient's complaint received by the authorized body for the assessment and control over the quality of the provision of public services is subject to consideration within 15 (fifteen) working days from the date of its registration.

In cases of disagreement with the results of the provision of public services, the service recipient shall apply to the court in the manner prescribed by the legislation of the Republic of Kazakhstan.

11. Persons enrolling in scientific-pedagogical magistracy shall take CT, including a test in a foreign language (optionally English, German, French), a test on the profile of educational programs groups, a test to assess preparedness for training in the Kazakh or Russian language.

Persons enrolling in a specialized magistracy with the Kazakh or Russian language of training shall take CT, which includes a test on the profile of educational programs groups and a test to assess preparedness for training in the Kazakh or Russian language optionally.

Persons enrolling in profile magistracy with English as the language of training shall take CT, which includes a test on the profile of educational programs groups in English and a test to assess preparedness for training in Kazakh or Russian or English.

Persons enrolling in the magistracy on groups of educational programs that require creative training shall take:

- 1) CT, including a test in a foreign language (optionally English, German, French), a test to assess preparedness for training in Kazakh or Russian.
  - 2) two creative exams on the profile of educational programs groups.

Persons enrolling in the magistracy on groups of educational programs requiring knowledge of the Arabic language shall take:

- 1) admission exam in Arabic;
- 2) CT, including a test to assess training preparedness, a test according to the groups of educational programs profile, optionally in Kazakh or Russian.

12. CT shall be conducted in accordance with the Rules for conducting comprehensive testing, approved by Order No. 190 of the Minister of Education and Science of the Republic of Kazakhstan dated May 8, 2019 (registered in the Register of State Registration of Regulatory Legal Acts under No. 18657).

CT shall be conducted by the National Testing Center of the Ministry of Education and Science of the Republic of Kazakhstan (hereinafter - NTC) at the CT location, designated by the Ministry of Education and Science of the Republic of Kazakhstan (hereinafter - MES RK)

.

Based on the CT results, an electronic certificate shall be issued, which is confirmed on the website of the National Testing Center of the Ministry of Education and Science of the Republic of Kazakhstan.

Retake of the admission (creative) exams and CT in the year they were taken is not allowed.

Creative exams on the profile of educational programs groups shall be conducted in accordance with Appendix 1 to these Model Rules.

Creative examinations on the profile of educational programs groups that require creative preparation shall be conducted independently by the OHPE, implementing admission to postgraduate education programs. The applicant shall take creative exams in the profile of educational programs groups of postgraduate education in the OHPE, in which he is enrolling

.

For the period of conducting creative examinations to magistracy, the OHPE shall form admission committees for groups of educational programs that require creative training. It is allowed to form one admission committee in related areas of professionals training.

The admission committees shall be comprised of the OHPE faculty members that hold doctor or candidate of science degree, or the degree of Doctor of Philosophy (PhD) in the relevant profile and their composition shall be approved by order of the head of the OHPE or the person acting in his capacity with the election of chairmen of the committees from among the members of the committee.

The admission committee shall not include members of the appeal committee.

Creative exam programs shall be developed by the OHPE and approved by the chairman of the OHPE admission committee.

The schedule of creative exams (the form of the exam, the date, time and venue, consultations) shall be approved by the chairman of the admission committee and brought to the applicants' notice before starting the acceptance of documents.

Creative exams shall be held in classrooms (premises) equipped with video and (or) audio recording.

The creative exam results shall be documented in a score sheet with a protocol of the committee in any form, which are transferred to the executive secretary of the admission committee (his deputy) for announcement of the results. The protocol of the committee shall be signed by the chairman and all the committee members present.

OHPE, regardless of the form of ownership, within 3 (three) calendar days after the creative exam completion, shall submit to the authorized education body the final report on the organization and conduct of the creative exam in any form, as well as copies of orders on the creative exam results.

Based on the creative exams results, the admission committee of the OHPE shall issue an extract from the score sheet for admission to the OHPE on a fee basis, regardless of the taken creative exams venue.

The admission exam in Arabic shall be conducted in writing independently by the OHPE, which admits students to postgraduate educational programs. The applicant shall take an admission exam in Arabic at the OHPE, in which he is enrolling.

For the period of the admission exam in the Arabic language, an admission committee shall be created in the OHPE.

The admission committee shall be formed from among the OHPE teaching faculty members, that hold doctor or candidate of science degree, or the degree of Doctor of Philosophy (PhD) in the relevant profile and its composition is approved by order of the head of the OHPE or the person acting in his capacity with the election of the chairman of the committees from among the members of the committee.

The admission committee shall not include members of the appeal committee.

The programs for the admission exam in Arabic shall be developed by the OHPE and approved by the chairman of the admission committee of the OHPE.

The schedule of the Arabic language exam (date, time and venue, consultations) shall be approved by the chairman of the admission committee and brought to the applicants' notice before the start of the documents acceptance.

The admission exam in Arabic shall be held in classrooms (premises) equipped with video and (or) audio recording.

The results of the Arabic language exam shall be documented by a score sheet and the protocol of the committee in any form, which are transferred to the executive secretary of the selection committee (his deputy) for the announcement of the results. The protocol of the committee shall be signed by the chairman and all the committee members present.

Based on the admission exam results in Arabic, the admission committee of the OHPE shall issue an extract from the score sheet for admission to the OHPE on a fee basis, regardless of the venue of the exam in Arabic.

13. Persons enrolling in residency shall take an admission exam according to the curricula group profile.

The admission exam on the curricula group profile of residency shall be conducted independently by healthcare educational organizations, OHPE and scientific organizations that enroll in postgraduate education programs. An applicant shall take an admission exam for a postgraduate education program in healthcare educational organizations, OHPE or a scientific organization in which he is enrolling.

For the period of admission examinations to residency, the admission committees for groups of educational programs shall be created in healthcare educational organizations, OHPE or a scientific organization. It is allowed to create one examination committee in related personnel training areas.

The admission committee shall not include members of the appeal committee.

14. Persons who have one of the international certificates of foreign language proficiency in accordance with the European competencies (standards) of foreign language proficiency shall be exempted from the test in a foreign language in CT to the magistracy in the following languages:

English: IELTS Academic (International English Language Testing System Academic), threshold score - at least 6.0;

TOEFL IBT (Test of English as a Foreign Language Internet-based test), threshold score - at least 60;

TOEFL PBT (Test of English as a Foreign Language Paper-based test), threshold score - at least 498;

German: Deutsche Sprachpruefung fuer den Hochschulzugang (DSH, Niveau C1/level C1), TestDaF-Prufung (NiveauC1/level C1);

French: TFI (Test de Français International<sup>TM</sup>) - not lower than level B1 in reading and listening sections, DELF (Diplome d'Etudes en Langue française) - level B2, DALF (Diplome Approfondi de Langue française) - level C1, TCF (Test de connaissance du français) - at least 50 points.

Persons enrolling in magistracy for educational programs groups in "Pedagogical Sciences", "Natural Sciences, Mathematics and Statistics", "Information and Communication Technologies", "Engineering, Processing and Construction Industries", as well as training areas "Humanities", "Social Sciences", "Business and Management" shall be exempted from CT for magistracy with Kazakh or Russian languages of instruction if they hold an international certificate of passing the standardized GRE test (Graduate Record Examinations ) with scores in accordance with Appendix 2 to these Model Rules.

Persons enrolling in magistracy for educational programs groups in "Pedagogical Sciences", "Natural Sciences, Mathematics and Statistics", "Information and Communication Technologies", "Engineering, Processing and Construction Industries", as well as training areas "Humanities", "Social Sciences", "Business and Management" shall be exempted from CT for magistracy with Kazakh, Russian or English languages of instruction if they hold an international certificate of passing the standardized GRE test (Graduate Record Examinations ) with scores in accordance with Appendix 3 to these Model Rules.

Persons enrolling in magistracy for educational programs groups in "Business and Management" training direction shall be exempted from CT for magistracy with Kazakh, Russian or English languages of instruction if they have an international certificate of passing the standardized GMAT test (Graduate Management Admission Test) with scores in accordance with Appendix 4 to these Model Rules.

When filing documents for the competition for an educational grant, and also when enrolling in the OHPE, the authenticity and validity of the provided certificates shall be checked by the OHPE admission committees.

To persons who have one of the certificates of passing a test in a foreign language (English, French, German) specified in this paragraph, when applying for the competition for the award of an educational grant at the expense of the republican budget or the local budget, and also when enrolling in OHPE on a fee basis 50 points are scored.

Persons who have completed foreign OHPE in countries whose state or official language is English and who have specialized accreditation of foreign accreditation bodies included in the registers and (or) associations of accreditation bodies of the member states of the Organization for Economic Cooperation and Development (OECD) within 5 years shall be exempted from testing block "Foreign language" (English) of CT to the magistracy with the Kazakh or Russian language of instruction.

15. Applicants to the magistracy in the application shall indicate one group of educational programs and up to 3 (three) OHPE.

The results of CT, entrance (creative) examinations shall be announced on the day they are held.

#### Paragraph 2. Admission and conduct of entrance examinations for doctoral studies

16. Persons shall be admitted to doctorate who have a master's degree and work experience of at least 9 (nine) months or who have completed residency training in medical specialties.

17. Persons entering doctoral studies, in the period from 22 to 28 August of the calendar year, shall submit to the service provider (through the admissions office of the OHPE) and (or ) through the portal a set of documents provided for in paragraph 8 of the Public Service Standard, in accordance with Annex 1-1 to these Model Rules.

The list of basic requirements for the provision of public services, including the characteristics of the process, the form, content, and result of the provision of services, as well as other information, taking into account the specifics of the provision of public services, is given in the Standard of Public Services.

Information about identity documents, higher education document, medical certificate, internship completion certificate shall be submitted to the service provider from the relevant state information systems through the "electronic government" gateway.

An employee of the service provider shall accept a set of documents, their registration and issuance of a receipt to the service recipient for the receipt of the set of documents on the day of receipt of the application, or, if the service recipient provides an incomplete set of documents, shall refuse to accept documents.

In case of contacting the service recipient through the portal, the status of acceptance of the request for public service is sent to the "personal account", as well as a notification indicating the date and time of receipt of the result of the public service.

The service provider, from the moment of their receipt, shall check the completeness of the documents submitted, in case of incompleteness, prepare a reasoned refusal of further consideration the application, which shall be sent in the form of an electronic document to the applicant in the "personal account" on the portal.

If the service recipient provides a full set of documents, the service provider shall be notified of the acceptance of documents for enrollment in the OHPE, after receiving the notification, the service recipient shall submit the original documents to the service provider by August 28 of the calendar year.

After receiving the documents, the head of the OHPE shall issue an order to enroll the service recipient in the number of doctoral students of the OHPE.

The service provider shall refuse to provide a public service on the grounds provided for in paragraph 9 of the Public Service Standard.

English: IELTS Academic (International English Language Testing System Academic) threshold score - at least 5.5;

TOEFL IBT (Test of English as a Foreign Language Internet-based test), threshold score - at least 46;

TOEFL PBT (Test of English as a Foreign Language Paper-based test), threshold score - at least 453;

TOEFL ITP (Test of English as a Foreign Language Institutional Testing Program), threshold score - at least 460;

German: Deutsche Sprachpruefung fuer den Hochschulzugang (DSH, Niveau B2/level B2), TestDaF-Prufung (Niveau B2/level B2);

French: TFI (Test de Français International<sup>TM</sup>) - not lower than B2 level in reading and listening sections), DELF (Diplome d'Etudes en Langue française) - level B2, DALF (

Diplome Approfondi de Langue française) - level B2, TCF (Test de connaissance du français) - at least 50 points.

The authenticity and validity of the provided certificates shall be checked by the OHPE admission committees.

Persons with a certificate (TOEFL ITP (Test of English as a Foreign Language Institutional Testing Program) shall take additional testing for proficiency in English before the start of the admission exam for doctorate program.

The number of test assignments in additional testing for the English language proficiency shall be 100. The maximum score shall be 100 points.

Additional testing for the English language proficiency is assessed in the form - "admission" or "non-admission". At least 75 points must be scored to qualify for admission.

Additional testing for the English language proficiency shall be conducted by the NTC in organizations designated by the authorized education body.

Applicants shall be notified of the date, time and venue of additional testing for the English language proficiency through their personal account.

Persons who have completed foreign OHPE in countries whose state or official language is English and who have specialized accreditation of foreign accreditation bodies included in the registers and (or) associations of accreditation bodies of the member states of the Organization for Economic Cooperation and Development (OECD) within 5 years are not required to provide international certificates of a foreign language proficiency in accordance with the European competencies (standards) of foreign language proficiency specified in this paragraph.

20. The admission exam for doctorate studies shall be held in paper or computer format.

The admission exam in paper format for groups of doctoral educational programs in accordance with Appendix 5 shall be held independently by the OHPE, which admits to doctoral educational programs. At the same time, the applicant shall take the admission exam for the group of doctoral educational programs only in the OHPE, in which he is enrolling.

The admission exam in computer format for groups of doctoral educational programs in accordance with Appendix 5 shall be held in organizations designated by the authorized education body.

Applicants shall be notified of the date, time and venue of the admission exams through their personal account.

The admission exam for groups of educational programs of doctoral studies in "Healthcare" field in accordance with Appendix 5 shall be held independently by the OHPE,

which admits to doctoral educational programs. At the same time, the applicant shall take the admission exam for the group of doctoral educational programs only in the OHPE, in which he is enrolling.

- 20-1. The admission examination for doctoral studies in computer format shall be comprised of:

  - 3) answers to examination questions on the educational program group profile.

The final grade is a set of points obtained by summing up the results of assessing essays, a test in preparedness for doctoral studies, answers to examination questions on the educational program group profile in accordance with Appendix 9.

- 4 hours (240 minutes) are allotted for the admission examination to doctoral studies, of which:
  - for the test in preparedness for doctoral studies 50 minutes;
- for writing essays and answers to examination questions on the educational program group profile 190 minutes (3 hours 10 minutes).

At the same time, disabled people with visual, hearing, and musculoskeletal disorders upon presentation of the document confirming disability, approved by order No. 44 of the Minister of Health and Social Development of the Republic of Kazakhstan dated January 30, 2015 "On Approval of the Rules for Medical and Social Expertise" (registered in the Register of State Registration of Regulatory Legal Acts under No. 10589) shall be provided with additional time of up to 60 minutes.

To start the admission exam in computer format, the applicant must:

- 1) enter the login;
- 2) enter the password;
- 1) log in through the scanner of the volume-spatial form of a person's face;
- 4) check out the rules for conducting an admission examination for doctoral studies in a computer format;
  - 5) confirm correctness of the data on the admission examination;
  - 6) after pressing the "Enter" button, proceed to the admission exam.

Upon completion of the admission exam, the answers to the blocks of essays and examination questions on the educational program group profile of the applicant are sent to the OHPE of their choice for processing and evaluation. The applicant's answers on the test block to assess preparedness for doctoral studies shall be processed by the NTC.

The results of the entrance exam shall be announced the next day after the admission exams.

Based on the results of the admission exam and (or) consideration of the application for appeal (in the case of filing an application for appeal), the applicant shall be issued an electronic certificate, which is published on the NTC website and sent to the applicant's personal account.

The electronic certificate of the admission exam is confirmed on the NTC website.

The certificate of the admission examination held between August 4 and 20 is valid until December 1 of the current calendar year;

The certificate of the admission examination held between November 18 and December 11 is valid until March 1 of the next calendar year.

20-2. The OHPE shall approve essay topics, questions on the profile of the educational program group by the collegial governing body two months before the start of the admission exams and place essay topics approved by the collegial governing body, questions on the profile of the educational program group on the official websites of the OHPE.

Footnote. The model rules have been supplemented by paragraph 20-2 in accordance with Order No. 241 of the Minister of Education and Science of the Republic of Kazakhstan dated 24.05.2021 (effective after the date of its first official publication).

20-3. To monitor compliance with the rules for conducting an admission exam in a computer format in organizations designated by the authorized education body, administrators of admission exams and supervisors from among the employees of the authorized education body, interested state bodies and departments, representatives of civil society institutions, non-governmental organizations shall be assigned. Administrators of admission examinations perform the functions of a duty attendant in the classroom and along the corridor.

Applicants are let in for the enrollment exam in a computer format one at a time and the identity of the applicant is identified through a scanner of the volume-spatial form of a person's face on the basis of an ID or passport.

During admittance for the enrollment exam in a computer format, hand-held and frame-type metal detectors are used.

When prohibited items are detected (mobile communication items equipped with information transfer functions, smart watches, wired and wireless headphones, crib notes, courseware guides), during a metal detector check at admittance to the exam, the enrollment exam administrator shall report on identified prohibited items at the admittance to the entrance exam for doctoral studies in a computer format in accordance with Appendix 10 to these Rules, and the applicant is not allowed to take the enrollment exam in the current year.

If a "put-up person" is identified during the admittance to the enrollment exam, the administrator of the enrollment examination shall draw up a report on identified put-up test taker at the admittance to the enrollment exam for doctoral studies in a computer format according to the form of Appendix 11 to these Rules, the applicant shall be denied entrance for this admission exam.

Applicants who have involved "put-up persons" shall not be allowed to take the admission exam in the current year.

Footnote. The model rules have been supplemented by paragraph 20-3 in accordance with Order No. 388 of the Minister of Education and Science of the Republic of Kazakhstan dated 09.08.2021 (effective after the date of its first official publication).

- 20-4. When conducting an enrollment exam to doctoral studies in a computer format, an applicant is not allowed to:
- 1) leave the classroom without the permission and escort of the enrollment exam administrator, performing the functions of the audience attendant;
  - 2) leave the room more than 2 times for more than 10 minutes;
  - 3) to talk, change seats;
- 4) exchange documents and A4 paper sheets, given to the applicant for answers to examination questions on the profile of the educational program group;
- 5) take out of the room documents and paper of A4 format, given to the applicant for answers to examination questions on the profile of the educational program group;
- 6) bring into the classroom and use crib notes, education literature, a calculator, a camera, mobile communications (cell phones, tablets, iPad, iPod, Smartphone, laptops, players, modems (mobile routers), use any type of electronic communication (Wi-Fi, Bluetooth, Dect, 3G, 4G, 5G, smart watches, wired and wireless headphones, etc.)
- 7) deliberately damage equipment for the use of the enrollment exam and the security system.

At the same time, it is allowed to use a calculator, Mendeleev's periodic table and salts solubility table in the interface for the computer enrollment exam.

If the applicant is revealed to have the items specified in this paragraph, as well as in case of violation by the applicant of this rule at the enrollment exam, the administrator of the enrollment exam, together with the supervisors, shall draw up a report on detected prohibited items during the enrollment exam to doctoral studies in computer format and expulsion from the room of the applicant, who broke the rules of conduct in the audience in accordance with Appendix 12 to these Rules. The applicant is expelled from the room. The enrollment exam results are not processed and shall be annulled.

If a put-up person is detected during the enrollment exam, the administrator of the enrollment exam, together with the supervisors, shall draw up a report on identified put-up

person during the enrollment exam to doctoral studies in a computer format in accordance with the form in Appendix 13 to these Rules. The put-up person shall be expelled from the room. The enrollment exam results are not processed and shall be annulled.

Those who involved "put-up persons" in the enrollment examination are not allowed to take the enrollment examination to doctoral studies in the current year.

20-5. NTC, after completing the admission examination for doctoral studies in a computer format, held from August 4 to 20, shall review video surveillance recordings for 3 (three) months.

NTC, after completing the enrollment examination for doctoral studies in computer format, held from November 18 to December 11, shall review video surveillance recordings for 3 (three) months.

In case of detected use by the applicant during the enrollment examination of prohibited items referred to in paragraphs 20-3 and 20-4 of these Rules, the NTC shall draw up a report on the detected use of prohibited items during the enrollment examination to doctoral studies in computer format and direct it to the authorized education body with supporting materials.

The report on the discovered use of prohibited items during the enrollment exam and supporting materials shall be submitted for consideration by the commission created by the authorized education body.

On the decision of the commission, the enrollment exam certificates are annulled by the order of the authorized education body.

After the annulment of the enrollment examination certificate, the OHPE shall send a notification to the applicant.

- 21. For the period of the entrance examinations for doctoral studies examination committees for groups of educational programs shall be created in the OHPE. It is allowed to create one examination committee in related areas of personnel training.
- 22. Examination committees on educational programs groups shall be formed from among the teaching faculty members of the OHPE, faculty members of the OHPE with a doctorate or candidate of science degree, or a PhD degree in the relevant profile.

The examination committee shall not include members of the appeal committee.

The composition of the examination committees, indicating their chairmen, shall be approved by order of the head of the OHPE and sent to the authorized education and healthcare body.

The OHPE examination committees shall grade the papers on the individual code of the applicant and send the examination results through the information system to the NTC for further publication of the results.

Persons enrolling in the groups of educational programs in "Pedagogical Sciences", "Natural Sciences, Mathematics and Statistics", "Information and Communication Technologies", "Engineering, Processing and Construction Industries", and also training areas "Humanities", "Social Sciences", "Business and Management" shall be exempted from enrollment examinations for doctoral studies in the presence of an international certificate of passing the standardized test Graduate Record Examinations (Graduate Record Examinations) GRE with scores in accordance with Appendix 6 to these Model Rules.

The authenticity and validity of the submitted certificates shall be checked by the OHPE admission committees.

#### Paragraph 3. The work of the appeal committees

- 23. OHPE and scientific organizations, twenty calendar days before the entrance (creative) examinations, shall send to the Ministry of Education and Science of the Republic of Kazakhstan and the Ministry of Health of the Republic of Kazakhstan the schedule of entrance (creative) examinations for groups of educational programs of doctoral, magistracy, residency.
- 24. For consideration of applications of persons who do not agree with the results of entrance (creative) examinations in the OHPE and scientific organizations, appeal committees shall be created. The chairpersons and composition of the appeal committees in the OHPE and scientific organizations shall be approved by the order of the chairperson of the admission committee.

To consider applications of persons who do not agree with the results of CT, a Republican appeal committee shall be created under the MES of the Republic of Kazakhstan. The chairperson and composition of the Republican Appeal Committee shall be approved by Order of the Ministry of Education and Science of the Republic of Kazakhstan.

When conducting CT in paper format, appeal committees shall be created at each CT location. The chairpersons of the appeal committees shall be approved by the Order of the Ministry of Education and Science of the Republic of Kazakhstan.

25. The appeal committee shall accept and consider the applications from persons entering doctoral studies and residency on the content of examination materials and technical reasons.

The Republican Appeal Committee shall consider applications from persons entering the magistracy on the content of test tasks and technical reasons.

The appeal committee and (or) the Republican Appeal Committee make a decision on the application of the person appealing the results of the entrance (creative) examination or CT for groups of educational programs of postgraduate education.

26. An application for an appeal from persons applying for doctoral studies, residency, magistracy shall be submitted to the chairman of the appeal commission by applicants personally and (or) through the information system of the NTC.

Applications shall be accepted until 13:00 the next day after announcement of the results of the enrollment exam for doctoral studies, creative exams and CT and are considered by the OHPE appeal commission within one day from the application date.

An application for an appeal on the enrollment examination to doctoral studies in computer format shall be accepted the next day from 13:00 to 13:40 after announcement of the results, on the basis of an organization designated by the authorized education body.

When coming in for the appeal on the enrollment exam results, the use of prohibited items referred to in paragraphs 20-3 and 20-4 of these Rules is not allowed.

If prohibited items referred to in this paragraph are detected during a metal detector check at the admittance to testing, the testing administrator shall draw up a report on the expulsion from the premises of the applicant upon detection of prohibited items when entering the CT premises in accordance with the form in Appendix 10 to these Rules. The applicant shall not be allowed to retake the test in the current year.

An appeal from persons applying for doctoral studies on the content of the test assignments and technical reasons on the test block to assess preparedness for doctoral studies shall be considered by the Republican appeal commission.

An application for an appeal on the test block to assess preparedness for doctoral studies for technical reasons is submitted by applicants during the enrollment exam.

An appeal for a technical reason is considered if a fragment of the test task (texts, diagrams, figures, tables) is missing, as a result of which it is impossible to determine the correct answer.

The specific facts stated in the application for appeal are subject to consideration.

40 minutes are allotted for the appeal on the enrollment examination to doctoral studies in a computer format, of which:

- 1) for the test block on preparedness for doctoral studies 10 minutes;
- 2) on writing an essay block and answering examination questions on the profile of the educational program group 30 minutes.

An appeal on the content of test items is considered in the following cases:

- 1) the correct answer does not match the code of the correct answers (the variant of the correct answer must be indicated);
  - 2) there is no correct answer;
- 3) there is more than one correct answer in test tasks with the choice of one correct answer from all offered (all options of correct answers are indicated);
  - 4) incorrectly composed test assignment.

When submitting an application on the content for reviewing test assignments, the applicant shall indicate reasoned grounds (full explanation).

Applications for appeal to review all test assignments without indicating a motivated reason (full explanation, step-by-step problem solving) are not subject to consideration.

An appeal on the results of writing an essay and answers to examination questions on the profile of the group of the educational program shall be considered by the appeal commissions of the OHPE.

- 27. When considering an application by the appeal committee, the person who submitted the appeal shall provide an identity document.
- 28. Decisions by the appeal committees shall be made by a majority vote of the total number of members of the committee. In case of equality of votes, the vote of the chairperson of the committee is decisive. The work of the appeal committees shall be documented in a protocol signed by the chairperson and all members of the committee.
- 29. In order to maintain order during the entrance examinations and CT, representatives of the Ministry of Education and Science of the Republic of Kazakhstan shall be sent to the CT and OHPE points.

## Paragraph 4. Enrollment in educational institutions implementing educational programs of postgraduate education

30. Enrollment in the scientific-pedagogical magistracy on a fee basis shall be based on the CT results in accordance with the Scale of 150-point grading system in CT for the magistracy with the Kazakh or Russian language of training in accordance with Appendix 7 to these Model Rules (hereinafter - Appendix 7): not less than 75 points, while in a foreign language - at least 25 points, on the profile of a group of educational programs: with the

choice of one correct answer - at least 7 points, with the choice of one or more correct answers - at least 7 points, on the training preparedness test - at least 7 points.

Enrollment in a specialized magistracy with the Kazakh or Russian language of training on a fee basis shall be based on the CT results in accordance with the Scale of 100-point grading system in CT for the specialized magistracy with the Kazakh or Russian language of training in accordance with Appendix 7-1 to these Model Rules (hereinafter - appendix 7-1): at least 50 points, while on the test for assessing preparedness for learning - at least 7 points, on the profile of the educational programs group: with the choice of one correct answer - at least 7 points, with the choice of one or more correct answers - at least 7 points.

Enrollment in specialized magistracy with English as the language of training on a fee basis is based on the CT results in accordance with the Scale of 100-point grading system in CT for the specialized magistracy with English as the language of training in accordance with Appendix 8 to these Model Rules (hereinafter Appendix 8): at least 50 points, while on the test for assessing preparedness for learning - at least 7 points, according to the profile of the group of educational programs: with the choice of one correct answer - at least 7 points, with the choice of one or more correct answers - at least 7 points.

Enrollment in the magistracy on groups of educational programs that require creative training on a fee basis is based on the results of CT and creative exams in the profile of the group of educational programs in accordance with Appendix 7: at least 75 points, while in a foreign language - at least 25 points, on the test for assessing preparedness for learning - at least 7 points and on creative exams - at least 7 points on each creative exam.

For each creative exam, the maximum number of points shall be 35.

Enrollment in the magistracy on groups of educational programs requiring knowledge of the Arabic language on a fee basis is based on the results of the enrollment exam in Arabic and CT according to Appendix 7: at least 75 points, while in Arabic - at least 25 points, on the profile of the educational programs group: with the choice of one correct answer – at least 7 points, with the choice of one or more correct answers - at least 7 points, on the test determining readiness for learning - at least 7 points.

Persons seeking admission to the magistracy are enrolled in the OHPE if they score the passing threshold points established by the OHPE.

Persons are admitted to residency based on the results of the enrollment examination in the educational programs group profile and who scored at least 75 points out of a possible 100 points.

Enrollment in doctoral studies on a fee basis is carried out on the basis of an international certificate confirming proficiency in a foreign language in accordance with the all-European competencies (standards) of foreign language proficiency and based on the results of an enrollment exam in the profile of a group of doctoral educational programs and who scored at least 75 points out of a possible 100 points.

- 31. For training under the state educational order by competition, persons are enrolled who have scored the highest scores in CT and (or) enrollment exam and (or) creative exams:
- 1) for the scientific-pedagogical magistracy, including for educational programs groups that require creative training, for groups of educational programs that require knowledge of the Arabic language at least 75 points in accordance with Appendix 7;
- 2) for a specialized magistracy with Kazakh or Russian as the language of training at least 50 points in accordance with Appendix 7-1;
- 3) for a specialized magistracy with English as the language of training at least 50 points in accordance with Appendix 8;
  - 4) for residency at least 75 points.

Persons who scored at least 75 points in the admission exam are enrolled for doctoral studies under the state educational order by competition.

32. In the case of the same indicators of competitive scores, persons with the highest grade in the enrollment exam on the educational program group profile shall enjoy the priority right when enrolling in doctoral studies. Then, scores for essays, preparedness test scores, scientific achievements corresponding to the educational program profile shall be taken into account: scientific publications, including those in rating scientific publications included in the 1st, 2nd quartile according to the Journal Citation Reports of the Web of science database Clarivate Analytics over the last 3 calendar years; certificates of scientific developments; certificates of awarding scientific scholarships, grants; certificates/diplomas for participation in scientific conferences and competitions.

33. Unfilled student seats under the state educational order for doctoral studies, including targeted ones, shall be returned to the authorized bodies in education, healthcare and culture in the form of an application for further redistribution among OHPEs in the context of groups of educational programs of postgraduate education until September 5 of the calendar year.

34. OHPE and scientific organizations shall submit to the authorized bodies in the field of education, health care, and culture within 10 calendar days a final report on the organization

and conduct of admission, as well as copies of orders for enrollment in magistracy, residency, and doctoral studies on the state educational order.

## Chapter 3. Admission to training in educational organizations implementing educational programs of postgraduate education at the expense of the local budget

- 35. To participate in the competition for the state educational order at the local budget expense, applicants shall file to the OHPE until August 25 of the calendar year:
  - 1) application (in any form);
  - 2) document on higher education (original);
- 3) a CT certificate and a copy of the certificate of passing the test on the programs specified in paragraph 14 of these Rules (if any) and a transcript on passing the (creative) exam for groups of educational programs indicating points (if any) (for magistracy);
  - 4) a transcript on passing the enrollment exam indicating points (for residency);
- 5) a certificate of a foreign language proficiency in accordance with the all-European competencies (standards) of foreign language proficiency and a transcript on passing the enrollment exam on groups of educational programs indicating points (for doctoral studies);
  - 6) a copy of the employment record book (if available);
  - 7) a copy of an ID;
- 8) the results of the preliminary selection (for doctoral studies in the education field "Health and social security (medicine)".

36. The competition for the state educational order shall be held in accordance with the points of CT and/or the entrance (creative) examination for groups of educational programs.
